- 29.97 frames per second is preferred (but can also work with 23.98 or 59.94)
- Audio: 48k, 16 bit, Stereo
- Codec either Apple Pro Res or H264
- HD Note: All HD films will be letterboxed in the final mix.
- If you are doing SD (4:3)
- A QuickTime File 720 x 486
- 29.97 frames per second
- Audio: 48k, 16 bit, Stereo
- Codec either Apple Pro Res or H264

DVD's may be either hand delivered or mailed to be received by February 1, 2012 with Entry Form and a Release Form completed for each performer.

- The Entrant shall be responsible for complying with all requirements of 18 USC 2257, relating to record keeping concerning the identity and date of birth of all performers. The Entrant represents, warrants and agrees that the Entrant is familiar with all these requirements and will comply with them. Acceptance or screening by The East Bay Express of the Film shall not relieve the Entrant from this obligation or constitute any warranty by The East Bay Express of any responsibility for these requirements.
- Nothing in this License, Release and Agreement constitutes a guaranty that the Film will win the Contest or any award in the Contest or that it will be screened, exhibited or publicized at any time. the East Bay Express will announce a policy at any public screening of the Film that unauthorized taping or recording of any portion of the Film is prohibited. However, the East Bay Express assumes no other responsibility to prevent unauthorized taping or recording.
